As empowered under Article (2) (2) (ii) of the Shillong Law College, the Governing Body of the College has considered it expedient to frame suitable rules for delegation of administrative and financial powers in connection with the administrative and academic affairs of the college. The Governing Body therefore resolved to frame and approve these rules vide its Resolution No. 3 at its special meeting held on the 4th July, 2009.

Part 'A' - These rules shall be called the Shillong Law College (Delegation of Administrative/Executive powers) Rules, 2009.
