MAJOR ACTIVITIES DURING 2021

- 1. 26th January Republic Day: 3.1 Republic Day: On the occasion of Republic Day the 26th January 2020 the Secretary of the College along with the Principal and Teaching and Administrative Staff and student hoisted the Indian National Flag at 8.00 AM with recitation of the National Anthem. A brief program was organized by the IQAC of the College in this occasion. The programme started with the National Anthem at 10.00 AM with the Inaugural Address by the IQAC Co-Ordinator Dr. (Ms) M. Kharshiing. The Secretary of the College Shri D. B. Gurung and the Principal highlighted many aspects of the Republic Day Celebrations. Vote of thanks were offered by Smt. Daiahunlin Mawlong, Asstt. Professor and NSS Programme Officer.
- 2. 5th June Webinar on Rain Water harvesting: The Shillong Law College IQAC Environment Committee organised a one-day webinar on the topic *Rain Water Harvesting: The Need of The hour*, in order to celebrate the world Environment Day on the 5th of June. There were two resource persons *Shri Manoj K. Das Managing Director NERAMAC & concurrently Head Advisory and consultancy NEDFi*who spoke about the needs and necessity of rain water harvesting in India especially in the present situation where we see water crises almost every parts of India. He explained by providing us with Power Point Presentation on how to harvest and store water, this has really enlighten our knowledge. *Secondly*, we had *Shri Treiborlang L. Jyrwa Advocate, the High Court of Meghalaya, Panel Lawyer for State and Central Government and others*, who elaborated various laws relating to rain water harvesting, he also highlighted the provisions from the Meghalaya Building Bye Laws 2021.

In this programme we have 45 (forty five) participants, who actively participated in this programme, there were questions raised by the participants which were answered by the resource persons.

The entire programme was for one hour i.e from 2.00 -3.00 P.M on the 5th June, 2021.

3. 21st June Virtual Training Programmed on Yoga Day Celebration: - The Shillong Law College NSS cell in collaboration with the Art of Living Shillongorganised a one-day virtual training programme on the topic YOGA PRACTICE: ITS IMPORTANCE AND IMPLIMENTATAION DURING COVID-19 PANDEMIC on the 21st June, 2021. There were two resource persons Smt. Suparna Mordani and Shri Prasanchit Deb who demonstrated a live training on yoga, followed by question-and-answer session. The meeting was chaired by Dr Umeshwari Dkhar, welcome speech was given by Dr Sharif Uddin, Principal Shillong Law College and the valedictory speech was delivered by Smt. Daiahunlin Mawlong.

The participants registered via google form whereby a link was provided in their registered email id. There were 75 (Seventy-Five) participants. The entire programme was for one hour.

4. 1st to 3rd July, 2021 - International Webinar on Multidisciplinary Socio-Economic and Cultural Studies- The Shillong Law College in collaboration with the Cape Comorine Trust, India organised a three days International Virtual Conference from the 1st to 3rd July on the topic Multidisciplinary Socio-Economic and Cultural Studies. There were 85 (Eighty-Five) paper presenters, 1 Keynote Speaker, 19 Chair Person, 9 Resource Persons and 106 participants from India and outside India. The convenor for this conference was Smt. DaiahunlinMawlong and Dr Umeshwari Dkhar was the organising secretary and five student-members of the Shillong Law College (Krishanu Deb, Kaniwanroi Deingdoh, Vishal Kumar, Mawshanbor Ryntathiang, and Mario Nongbri)

The conference started on the 1st of July with the inaugural function at 10.00AM.The programme was facilitated by Smt. Deiphisha Kurbah, the welcome speech was addressed by the Principal Shillong Law College, the inaugural speech was given by Dr M. Kharshiing and the Presidential speech was given by Shri D.B Gurung. The abstract was released by Daiahunlin Mawlong who was the convener of this conference.

The main session started with a speech from the keynote speaker Dr S.K Ramani whose topic was "Changing Perspective of Elderly Care in Contemporary society" where she discussed how aging in The Indian Society is seen as a burden, both socially and medically. 80% is dependent on others for their daily maintenance. Hence we need to act! We need the involvement and collaboration of family, community and government so as to ensure that growing old is an accomplishment and embrace it with dignity.

Various resource persons from different fields of study provided us with knowledge and input form their own subject of expertise.

There was technical session on the 2nd and 3rd July from 10:00 AM to 5.00PM every day. The programme concluded on the 3rd of July after the technical session with a valedictory speech from Smt. Eleane Marbaniang Assistant Professor Shillong Law College and a vote of thanks from the organising secretary Dr. Umeshwari Dkhar, Assistant Professor Shillong Law College.

- 5. 23 October 2021- District Legal Services Authority, EKH District Meghalaya in collaboration with the Legal Care and Support Centre, Shillong Law College organized a programme in which Hon'ble Mr. Justice H.S Thangkhiew, Judge The High Court of Meghalaya delivered a lecture and interacted with the student. 
